He served briefly as Airport Manager of Operations Training at Fort Lauderdale-Hollywood -International Airport and as a Subject Matter Expert for the Miami, Florida Police Dept's Training Division.

Mr. Walton is a well-known speaker and author on workplace violence-the insider threat, executive protection, identity theft, school safety, special event planning, dealing with angry customers, threat assessments, security surveys, and other security topics.
